

The tender addressed to the **Special Director General of Police cum Director of Fire & Emergency Services, Assam** must reach to the office of the undersigned upto 1:00 P.M. on 04.04.2019. The word "**tender call for Uniform items for Fire & Emergency Services & SDRF Bn. Personnel**" should be super scribed on the top of the tender cover. No tender received thereafter will be accepted. The Tender Box will be opened on the same day at 03.00 PM in presence of tenderers or their authorised representatives remain present at that time.



TERMS AND CONDITIONS:

1. All tenderer must submit their tenders along with following documents complete in all respect and duly attested by self/Govt. Gazetted Officer and details of which should also be indicated on their tender papers. Else their tender will be summarily rejected.
 - i. Tender documents duly completed and signed indicating the rate quoted.
 - ii. Up-to-date Trade License from Municipality/ Mahakuma Parishad/ Town Committee as applicable.
 - iii. Permanent Account No. (PAN) issued by Income Tax Department.
 - iv. GST Registration Certificate.
 - v. The tenders must be accompanied by Earnest Money of Rs. 10,000/- (Rupees ten thousand) in the form of Demand Draft from any Nationalized/ Scheduled bank duly Pledged in favour of **Special Director General of Police cum Director of Fire & Emergency Services, Assam, Panbazar, Guwahati.**
 - vi. Authority Certificate or Dealership Certificate from the Concerned Authority.
2. Tender should be clearly typed or written and the rate should be written in both figure and words in their own firm pad. There should not be any over writing, erasure in the rate. In case of over writing or erasure or any such alteration, the tender will be rejected outright.
3. Only one sample should be submitted against each item of **Uniform** with a label mentioning therein (i) The name and address of the tenderers, (ii) Name of the item.
4. The rate once quoted will be final and no request for change/ alteration will be entertained thereafter. The rate should be quoted **F.O.R. destination (i.e. at Office of the Special Director General of Police cum Director of Fire & Emergency Services, Assam, Panbazar, Guwahati - 01)** inclusive of packing transportation and other ancillary expenses. GST/Tax etc. if any, should be shown separately.
5. The Earnest Money of the unsuccessful tenderer (s) will be released to them after finalization of the tender and the earnest money of the successful tenderer (s) will be released to them only on receipt of security money from their end. Conversion of Earnest Money into security deposit may be considered on application.
6. The **Special Director General of Police cum Director of Fire & Emergency Services, Assam, Panbazar, Guwahati** is not bound to accept the lowest rate and reserves the right to reject any or all the tenders without assigning any reason thereof. The decision of the **Special Director General of Police cum Director of Fire & Emergency Services, Assam, Panbazar, Guwahati/Acceptance Committee** will be final and binding in this regard.
7. The suppliers must conform to the approved samples as prescribed by the **Special Director General of Police cum Director of Fire & Emergency Services, Assam, Panbazar, Guwahati.** In Case the suppliers do not strictly conform to the approved sample and are not made in the stipulated time, the same will not be accepted and security money will be forfeited to the Govt. cancelling the deed of agreement for the whole year.

All other terms and conditions are as per rules and procedures followed in Fire and emergency Services, Assam, Govt. of Assam from time to time are also applicable.
