(I) Educational Qualification and experience:

The post being considered is of Senior Consultant, the incumbent therefore must have the following required qualification:

1. B.E or B. Tech in Fire Safety Engineering or M.I Fire Engineering(U.K) with 10(ten) years of experience of working in regular Fire & Emergency Services Department.
2. Candidates should be well versed with National and International Codes and Standards with expertise in high rise and mixed use projects.
3. Minimum experience in the field of fire and life safety has to be substantiated through track record with proper documentation to substantiate the experience.
4. Govt. Officers who had retired from a post not below the Director of Fire & Emergency Services in other states/U.T or having equivalent rank of similar organisation would also be eligible for this position.

(II) Terms of Reference(Scope of Services):

1. Act as a Knowledge Partner and provide technical support to Fire & Emergency Services, Assam and assist in development of policies to ensure structural and fire safety in buildings and various occupancies.
2. Establish and maintain a knowledge management system on best practices for structural safety measures of buildings and infrastructure.
3. Examine the current policy, institutional , regulatory interfaces, bye laws, practices and processes and all technical aspects of Fire Prevention Wing which will generally include the following :
 - a) Issuance of Fire Safety No Objection Certificate.
 - b) Issuance of Renewal Fire Safety No Objection Certificate.
 - c) Issuance of Fire Attendance Certificate.
 - d) Fire Statistics.
4. The Consultant will identify the key clusters/regions/areas to be taken up for improvement of services delivery.
5. Any other work necessary for F&ES, Assam. (List is illustrative and not exhaustive. Additional points may include to it as the case may be).

(III) MODE OF OPERATION:

1. Consultant are to offer their services as and when the Director, Fire & Emergency Services decides to seek advice/guidance/opinion/comments or any issue pertaining to specific fields for delivery of the scope of services or as the case may be.
2. Any aspect pertaining to the subject matter to Administration. The consultant will guide accordingly.

3. The mode of communication will be through e-mail as well as personal visits. Airfare/T.A/D.A will be borne by F&ES Assam.
4. The consultant will also do hand holding of the Officer in actual discharge of the officer when requested.

(IV) **REMUNERATION:**

Indicative consolidated remuneration will be in the range of Rs. 75,000/- to Rs.1,00,000/- per month. Depending on qualification, experience and competency of the candidate, the salary is negotiable.
