1. Tender without Court fee stamp will not be accepted.
2. Tender received after fixed date and time will not be accepted.
3. Rates must be quoted item wise excluding all taxes and other charges on delivery at the office of the undersigned.
4. Modification of rates of any items will not be considered and Tenderer will be bound to provide the Net Connectivity on receipt of the formal order at the accepted rates during the financial year 2023-24.
5. Net connectivity must be operational within 7 (seven) days after receipt of formal order.
6. The undersigned reserves the right to accept or reject the lowest or all the Tenders without assigning any reasons thereof.
7. Tenderer must deposit EMD of Rs. 5,000/- (Rupees five thousand) only in the form of DD/MSC/KVP in favour of Spl. Director General of Police Cum Director of Fire & Emergency Services, Assam, Guwahati.
